### ***Example 1:***

Suppose you choose a jewellery weighing 15 grams with 16% making charges (VA) and the price of gold on that day is ₹3,000 you will get ₹33,000 / ₹3,000=11 grams for this 11 grams customers get No V. A. (Wastage) up to 15%, remaining 1% for that 11 grams (without prevailing discount offer) and excess quantity 4 grams with 16% making charges (VA) is applicable which have to be paid by customer and prevailing discount offer at the time can be extended and GST is applicable.

### ***Example 2:***

Suppose customer selecting 11 grams in Prince gold plus redemption and if customer select multiple items falling under different making charges (VA) like 2 studs are 5 grams with 16% VA then (as per terms, waiver of making charges (VA) up to 15% upper limit or an actual whichever is lower) for 5 grams with 16% making charges (VA) will be waiver of and for 6 grams with 16% making charges (VA) then up to 15% making charges (VA) will be waiver of and remaining 1% for the 6 grams has to be paid by customer, and if customer select multiple items falling under different making charges (VA) like 2 studs are 5 grams with 16% VA then (as per terms, waiver of making charges (VA) up to 15% upper limit or an actual whichever is lower) for 5 grams with 16% making charges (VA) will be waiver of and for 6 grams with 16% making charges (VA) then up to 15% making charges (VA) will be waiver of and remaining 1% for the 6 grams has to be paid by customer.

## ***Terms & Conditions***

---

1. Every month's installment amount in the multiples of ₹500/- should be paid on or before end of the month.
2. Collection of receipt from Prince Gold Plus advance purchase plan for amount remitted is mandatory. In case payment mode is through cheque/PDC/ECS/NEFT/RTGS then after realization in our account, receipt can be obtained or sent through courier. (Cheques / Drafts should be drawn in favour of 'PRINCE GOLD AND DIAMONDS INDIA PRIVATE LIMITED')
3. Cash will not be refunded under any circumstances; only gold jewellery/gold coin can be purchased.
4. An Authorization letter from the enrolled person is needed if the joint person or Nominee cannot make it in person for purchasing.
5. Becoming a member of one or more plan is possible (clubbing one or more order is possible in this plan but ordered date should be in the same date)
6. Excess advance amount paid will not be adjusted against the default months instead it will be only treated for upcoming months.
7. Ordered design can be charged for an alternate design on the maturity date or any time during the scheme period.
8. GST is applicable.
9. Members should produce their identity proof at the time of joining and at the time of redemption, along with receipts.
10. All kinds of stones in the jewellery are chargeable (waiver of making charges (VA) is applicable only on 916 Gold Jewellery) Any dispute would be subject to Chennai jurisdiction only.
11. In case of any change in the policy of Government regarding GST, the same shall be fully bore by the customer/member.
12. It is the sole discretion of the company to accept or reject any membership.
13. You can redeem the advance purchase plan where you have joined outlet only.
