STEP 1

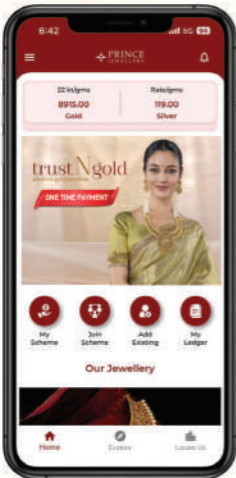
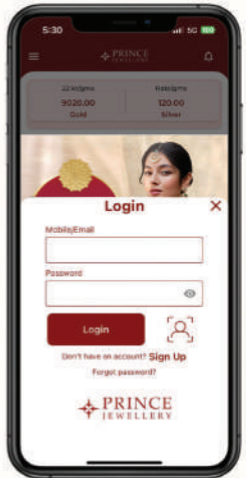
Download the Prince Jewellery App on your mobile phone from the App store or Google Play

Frequently Asked Questions (FAQ)

How to make the advance payment?

Payments can be made through Cash / Credit Card / Debit Card / PAYTM / RTGS / NEFT / Old Jewels/Gold bars (22KT/24KT)/Gold Coins. Respect of local cheques it shall be drawn in favor of "Prince Gold and Diamonds India Private Limited" subject to realization. However cash payment cannot be made for more than Rs.1,99,000 as per Government of India regulations. In case of cheque dishonor, the bank charges will be borne by the customers. The payment can be made at any Prince Jewellery showroom in india or online www.princejewellery.com or by downloading the Prince Jewellery savings app.

What if I discontinue?

Customers who choose to discontinue within 5th months of enrolment will not be eligible for any benefit/discount on wastage (VA) and can redeem only to the extent of accumulated gold weight under the plan. However, if the customer discontinues during 6th month of enrolment, the customer can purchase Gold jewellery with V.A. charges upto 6%, V.A. charges in excess of 6% has to be borne by the customer. If the customer discontinues during 7th month of enrolment, the customer can purchase Gold jewellery with V.A. charges upto 7%, V.A. charges in excess of 7% has to be borne by the customer. If the customer discontinues during 8th month of enrolment, the customer can purchase Gold jewellery with V.A. charges upto 8%, V.A. charges in excess of 8% has to be borne by the customer. If the customer discontinues during 9th month of enrolment, the customer can purchase Gold jewellery with V.A. charges upto 9%, V.A. charges in excess of 9% has to be borne by the customer. If the customer discontinues during 10th month of enrolment, the customer can purchase Gold jewellery with V.A. charges upto 13%, V.A. charges in excess of 13% has to be borne by the customer. The above benefits is applicable upto 18% V. A. only.

Will there be GST?

Yes, GST and any other Government levies will be borne by the customer at the time of delivery.

Frequently Asked Questions (FAQ)

What if I buy jewellery exceeding my accumulated weight?

If the weight accumulated under the plan is 10.00 grams. At the end of 11th month if the jewellery chosen is of 18 grams and the VA is 18%, you are eligible for No V.A. upto 18% for the accumulated weight of 10.00 grams, and 18% V.A. is applicable for the remaining 8.00gms, the wastage (VA) as applicable will be borne by the customer at the prevailing gold rate.

How do I know the weight accumulated?

This will be mentioned in the customer bond at the time of making the one time advance payment.

Can I buy Gold Coins?

Yes, you can purchase gold coins with No Wastage (VA).



Term and conditions

1. This is a jewellery advance booking. No refund of money or No old jewels will be returned under any circumstances under this advance booking.
2. This advance booking is unique and will not be linked to any existing or future advance bookings/offers and is not transferable under any circumstances.
3. The money paid as advance under this advance booking shall not bear any interest.
4. Minimum booking amount is Rs.25,000/-. There is no CEILING for the maximum amount and a copy of PAN is to be furnished for amount exceeding Rs. 2,00,000/-.
5. In this advance booking MINOR CANNOT BECOME AN APPLICANT/MEMBER.
6. At the time of joining this advance booking, the member may appoint a NOMINEE by furnishing KYC of both self and the nominee.
7. Payments can be made through Cash / Credit Card / Debit Card / PAYTM / RTGS / NEFT / Old Jewels/Gold bars (22KT/24KT)/Gold Coins. Respect of local cheques it shall be drawn in favor of "Prince Gold and Diamonds India Private Limited" subject to realization.
8. In case of dishonor of cheques, actual bank charges (RS.200 to RS.500 as the case may be) shall be borne by the member.
9. Members should ensure to collect customer bond while making payment directly at the respective branch.
10. Members will get credit in gold (22kt) units in grams credited according to the payment made as per the gold rate prevailing on date of the payment in the respective state and showroom.
11. In case of closing after 6 MONTHS (180 days) all types of Gold jewellery with V.A. Charges upto 6% can be purchased under this advance purchase plan with No V.A. Charges. (V.A. Charges in excess of 6% has to be borne by the customer.)
12. In case of closing after 7 MONTHS (210 days) all types of Gold jewellery with V.A. Charges upto 7% can be purchased under this advance purchase plan with No V.A. Charges. (V.A. Charges in excess of 7% has to be borne by the customer.)
13. In case of closing after 8 MONTHS (240 days) all types of Gold jewellery with V.A. Charges upto 8% can be purchased under this advance purchase plan with No V.A. Charges. (V.A. Charges in excess of 8% has to be borne by the customer.)
14. In case of closing after 9 MONTHS (270 days) all types of Gold jewellery with V.A. Charges upto 9% can be purchased under this advance purchase plan with No V.A. Charges. (V.A. Charges in excess of 9% has to be borne by the customer.)
15. In case of closing after 10 MONTHS (300 days) all types of Gold jewellery with V.A. Charges upto 13% can be purchased under this advance purchase plan with No V.A. Charges. (V.A. Charges in excess of 13% has to be borne by the customer.)

Term and conditions

16. In case of closing after 11 MONTHS (340 days) all types of Gold jewellery, V.A. Charges upto 18% can be purchased under this advance purchase plan with No V.A. Charges. (V.A. Charges in excess of 18% has to be borne by the customer.)
17. Diamond Jewellery can be purchased under this advance purchase plan with No V.A upto 18% on Value Addition (V.A. Charges in excess of 18% has to be borne by the customer), 50% off on 18% Value Addition (V.A) on Ruby/Emerald & Uncut Diamond Jewellery (V.A. Charges in excess of 18% has to be borne by the customer), 15% off on paid up value for Tia (Daily wear from Prince) Diamond Jewellery, 10% off on paid up value on Platinum Jewellery. This is applicable only for the weight booked while joining the advance purchase plan.
18. The time period for redemption/purchase shall not exceed 365 days from the commencement date of the advance booking.
19. In case of the balance amount, if any, left out in the advance booking account after adjusting the purchase plan, various items shall be made available such as gold coins for the member to purchase. Balance amount will not be refunded.
20. Applicable stone charges will be collected from the member for ornaments with ruby, emerald, zircon, special stones, etc. special items such as Oddiyanam, Nagas, Kumkumchimizh, Thirumangalam, etc., shall attract extra charges.
21. The original bond has to be surrendered at the time of redemption. The person who has signed the original membership bond should sign on the invoice at the time of purchase/redemption.
22. In case the member does not redeem the jewellery within 365 days from the enrollment date, sale invoice will be raised in the name of the member towards sale of jewellery, applicable GST on sale value will be paid to the Government and the ornaments weight due to the member will be held as "Stock in custody" by the company till the time the member takes delivery of the ornaments. The members will be communicated/informed by the company in this regard.
23. In case of change in address, loss of bond, the company should be kept informed without any loss of time.
24. The applicable GST has to be fully borne by the member, In case of increase in taxes or introduction of new levies/taxes, the same shall also be fully borne by the member.
25. The company reserves the right to alter, amend, add or delete part or whole of the privileges of the advance booking without prior notice or suspend the advance booking at any time. In such an event, money will not be refunded and the member shall purchase any item at the showroom equal to weight in grams.
26. Members can redeem only at the showroom where they have enrolled. REDEMPTION IS RESTRICTED TO RESPECTIVE STATE AND SHOWROOM.
27. All disputes are subject to jurisdiction of the competent court in Chennai.
